**CERTIFICATION PROCESS**

Vendors receive unique sets of randomly generated member-level test data, or “test decks,” which they process for each measure their HEDIS software calculates. The vendors’ results are compared to the expected results to determine if the software computed HEDIS correctly for numerators, denominators, and exclusions. If not, the vendors can correct the code, get a new deck, and repeat the process.

**PRODUCT OVERVIEW**

Innoapp iHEDIS is a SQL Server/ASP.NET based HEDIS reporting engine. iHEDIS calculates 60 measures, as well as the systematic hybrid samples, included in the NCQA’s HEDIS Software CertificationSM Program. iHEDIS determines rates and scores for all product lines: commercial, Medicare and Medicaid.

**PROCESS**

Innoapp receives and imports client data into the Innoapp iHEDIS engine. Once the HEDIS engine completes the rating process, clients access results via an integrated web portal. The web portal contains measure results, reports and capability to download the completed IDSS and PLS files for submission to NCQA by clients.

**FILE LAYOUT INFORMATION**

Innoapp provides a set of simple flat file layouts. As an additional service, Innoapp can perform dataconversion for clients into the required layouts.
